BoardStock XII day-pass tickets are required for access onto the resort property and the moorage tie-line during the main events on Saturday, September 29, and Sunday, September 30, 2007. Day pass tickets for those 13 years and older is \$20 per person per day. Youths ages 7 to 12 pay \$10 per person per day and children 6 years and under are free with a ticket-holding adult. Boat moorage and on-site parking is \$10 per vehicle/vessel per day. No day passes are required for the athlete-qualifying rounds on Thursday, September 27, and Friday, September 28.
